






Paratransit Vaccination Trips






Passenger Fares

CRRSAA

2021 Coronavirus Response & Relief Supplemental Appropriations Act (CRRSAA)

- 100% federal share (no local match)
- Cleveland Urbanized Area (CUZA)

\$74.3 million

- Includes GCRTA, Medina County Public Transit, Laketran, Akron Metro, PARTA, Geauga County
- Greater Cleveland RTA:

\$67.3 million

- NOACA to allocate the ADA/Disability/Paratransit (5310)
- Unsure at this time how much of the \$323,627 will be apportioned to GCRTA

Consolidated Appropriations Act of 2021

2021 Consolidated Appropriations Act (American Rescue Plan)

- \$1.9 trillion stimulus package
- President signed into law:

Friday, March 12, 2021

Cleveland Urbanized Area (CUZA)

\$150.3 million

- Includes GCRTA, Medina County Public Transit, Laketran, Akron Metro, PARTA, Geauga County (5307 Formula)
- Estimating \$136.0 million to GCRTA

"Rides for Community Immunity" Update

RTA awarded \$773,000 grant from ODOT Partnership with State of Ohio, City, County & ODH

- 10,000 All Day Passes distributed through social service agencies.

 Passes valid through May 8.

- GCRTA has played an active role in our community's mass vaccination effort.
- Free fixed route passes have been distributed throughout various communities by FEMA canvassers to overcome and remove transportation barriers for vulnerable and underserved demographics.

"Rides for Community Immunity" Update

- Free transportation on Paratransit has provided over 600 rides.
- A free parking/ADA shuttle from surface lots to all entrances of the Wolstein Center has provided 2,000 rides.
- Transit Police have assisted other law enforcement agencies to provide security and maintain flow of traffic around the Wolstein Center.

"Rides for Community Immunity" Update

- Stephanie Tubbs Jones Transit Center has been used by transit agencies throughout Northeast Ohio transporting those seeking vaccines.
- GCRTA in conjunction with Downtown Cleveland Alliance provided employees with priority codes for vaccination appointments.
- GCRTA has provided transportation planning assistance to numerous agencies and task forces for pop-up vaccination sites throughout Cuyahoga County.



State of Good Repair East 79th Street Station Rehabilitation







Construction was completed last month and is now open to customers. The East 79th Street Station represents the Authority's final Key Station in need of an ADA-related rehabilitation, completing a program that began in the 1990's.

State of Good Repair Tower City Track Rehabilitation







The reconstruction of Track 13 represents the final stage of the Tower City track rehabilitation project. As in earlier stages, the existing track and track bed were removed. A concrete slab foundation was poured, low vibration track was positioned above this slab and a second concrete pour was completed to embed the track. Track work is scheduled to be completed by April 25, 2021, returning the track to service.

- All buses should be fitted by mid-June




ADA Office Reopened April 5
