Section 1. That Chapter 281 is hereby enacted to read as follows:

CHAPTER 281 Engineering and Project Management Division

281.01 COMPOSITION.

297.03 EXECUTIVE DIRECTOR/CHIEF INFORMATION OFFICER.

There is hereby established in the Office of Information Technology the unclassified position of Executive Director/Chief Information Officer.
