FIXING THE RATES OF FARE TO BE CHARGED ON THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY, AND RESCINDING RESOLUTION NO. 1975-59 and RESOLUTION NO. 1975-67.

BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. Rates of fare to be charged on the Greater Cleveland Regional Transit Authority are hereby fixed as follows effective October 5, 1975, except as otherwise shown:

(2) Special Combination Tickets Eight (8) for \$1.00
(3) Express Fare (13¢ or special combination ticket) plus \$0.05
(4) Transfer No Charge
B. All other times:
(1) Local Cash Fare No Charge
(2) Express Fare No Charge

DOWNTOWN LOOP SERVICE FARES

(Transfers will be issued from Downtown Loop with payment of full Local or Express Fare)

STUDENT FARES

Kindergarten through Grade 12 (High School) on all school days and school related trips.

- (b) Special Combination Tickets . . Eight (8) for \$1.00
- (c) Express Fare (13¢ or special local ticket)Plus \$0.05
- Note: 1. Identification cards will be required for students in Grades 9 through 12.
 - 2. I.D. cards will be valid for one year.
 - 3. I.D. cards will be issued by the school in a controlled manner.
 - 4. Students fares apply to all students in school districts which participate in the State of Ohio fare reimbursement program and forward State Funds to the Greater Cleveland Regional Transit Authority.

CHILDREN'S FARES

Childred under six (6) years of age may ride free when accompanied by a passenger paying an adult full fare.

On Sundays and holidays, two (2) children under 12 years of age may ride free when accompanied by an adult using a weekly pass.

MISCELLANEOUS FARES

Greater Cleveland Regional Transit Authority employees and Pensioners with I.D. cards, and all duly appointed, regular, full-time Municipal and/or County police, fire, and law enforcement officers in uniform or upon showing their official badge and proper identification are permitted to ride free.

FARE FOR RIDES OUTSIDE CUYAHOGA COUNTY Rides wholly outside of Cuyahoga County. . . \$0.50 ·(a) (b) Through rides between Downtown Cleveland and Avon Lake (Lorain County) Route 31.
