

AUTHORIZING THE GENERAL MANAGER TO EXECUTE A CONTRACT FOR ARCHITECT-ENGINEER SERVICES WITH RODE, KAPLAN, CURTIS, WOODARD, FOR AN AMOUNT NOT TO EXCEED \$25,300.00

WHEREAS, the Greater Cleveland Regional Transit Authority selected Rode, Kaplan, Curtis, Woodard as the architect-engineer for Project No. 1 - Light Rail System ROW Improvements, by Resolution No. 1978-206, adopted July 18, 1978; and

WHEREAS, it has been determined that maintenance of the bridge of East 116th Street over the Light Rail ROW in the median of Shaker Boulevard is the responsibility of the Greater Cleveland Regional Transit Authority; and

WHEREAS, it has been determined that the physical condition of this bridge has deteriorated to the point that total replacement by the Greater Cleveland Regional Transit Authority is required; and

WHEREAS, the architect-engineer services required for this work can best be provided by Rode, Kaplan, Curtis, Woodard because they will be simultaneously providing services related to the improvement of the immediate surroundings of this bridge; and

WHEREAS, the separate contract for architect-engineer services as will be required for the reconstruction of the East 116th Street bridge over the Light Rail ROW which has been negotiated with Rode, Kaplan, Curtis, Woodard provides for the expenditure of funds in the amount of \$25,300.00.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to execute a contract with Rode, Kaplan, Curtis, Woodard for architect-engineer services as will be required for the replacement of the East 116th Street bridge over the Light Rail ROW in the median of Shaker Boulevard.

Section 2. That the said contract shall be consistent in all its terms and conditions with the separate contract to be executed simultaneously with Rode, Kaplan, Curtis, Woodard for architect-engineer services for Project No. 1 - Light Rail System ROW Improvements, of Capital Grant OH-03-0054.

Section 3. That the expenditure of not to exceed \$25,300.00 be and it is hereby authorized as the full cost for these architect-engineer services, all of which shall be GCRTA funds.

Section 4. That the said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 1978-252; insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
