

RESOLUTION NO. 1979 - 194

A RESOLUTION APPROVING CHANGES IN CLASSIFICATION AND RATE FOR FORMER EUCLID MUNICIPAL TRANSIT SYSTEM EMPLOYEES.

WHEREAS, the Mass Transit System Transfer Agreement between the City of Euclid and the Greater Cleveland Regional Transit Authority provides that all employees shall be employed by the Authority in positions at least equivalent to those they held with the City of Euclid Municipal Transit System.
