

RESOLUTION NO. 1981-217

FIXING THE RATES OF FARES TO BE  
CHARGED ON THE GREATER CLEVELAND  
REGIONAL TRANSIT AUTHORITY

BE IT RESOLVED by the Board of Trustees of the Greater Cleveland  
Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That effective August 9, 1981 the local and express fares  
for the Greater Cleveland Regional Transit Authority shall be increased by  
\$0.20 and \$0.25 respectively. That the weekly local pass shall be based on  
a multiple of 10 times the local fare and the monthly pass shall be based on  
a multiple of 40 times the local or express fare. Further, that all other fares  
shall be adjusted to reflect the new local or express fare.

Section 2. That the Rates of Fare to be charged on the Greater  
Cleveland Regional Transit Authority are hereby fixed as follows:

LOCAL FARES

(a) Cash Fare	.....	\$0.60
(b) Tickets	.....Five (5) for....	\$3.00
(c) Weekly Pass	.....	\$6.00
(d) Transfer	.....	No Charge
(e) Monthly Local Pass	.....	\$24.00

EXPRESS AND RAPID TRANSIT FARES

(a) Cash Fare	.....	\$0.75
(b) Tickets	.....Five (5) for....	\$3.75
(c) Express Transfer	.....	No Charge
(d) Fare with weekly pass, monthly local pass, local fare ticket or transfer with connecting local lines, plus	.....	\$0.15
(e) Monthly Express Pass - Unlimited riding on all GCRTA Lines within Cuyahoga County.....		\$30.00

SENIOR CITIZEN FARES/HANDICAPPED FARES (with identification card)

A. Weekdays between hours of 7:00 A.M. and 9:00 A.M.  
and 4:00 P.M. and 6:00 P.M.:

(1) Local Cash Fare .....	\$0.30
(2) Special Combination Tickets ..... Five (5) for..	\$1.50
(3) Express Fare \$0.37 or special combination ticket plus .....	\$0.07
(4) Transfer .....	No Charge

B. All other times:

(1) Local Fare .....	No Charge
(2) Express Fare .....	No Charge
(3) Transfer .....	No Charge

DOWNTOWN LOOP SERVICE FARES

(a) Cash Fare .....	\$0.25
(b) With passes or valid transfers from connecting lines .....	No Charge

(Transfers will be issued from Downtown Loop  
with payment of full Local or Express Fare)

STUDENT FARES

(a) Special school tickets purchased through School Boards.	
(b) Transfer .....	No Charge

NOTE: Special tickets will be available through Local School Boards. These tickets will be sold to School Boards 360 tickets for \$120.00 for Mandated Students and 180 tickets for \$60.00 for Students covered by Board Transportation Policy. Provided that the rate charged the School Boards shall be increased to reflect any increase in State allowance.

CHILDREN'S FARES

One child under six (6) years of age may ride free when accompanied by a passenger paying an adult full fare.

On holidays, two (2) children under 12 years of age may ride free when accompanied by an adult using a weekly or monthly pass.

On Sundays a maximum of three (3) children under 18 years of age may ride free when accompanied by an adult using a weekly, monthly or Sunday pass.

MISCELLANEOUS FARES

Greater Cleveland Regional Transit Authority employees and Pensioners with I.D. cards, and all duly appointed, regular, full-time Municipal and/or County police, fire, and law enforcement officers in uniform or upon showing their official badge and proper identification are permitted to ride free.

SUNDAY PASS

Sunday Pass: \$1.00

Valid for: Local, Express and Rail Transit Fares up to Four persons with a maximum of two (2) adults, 18 years of age or older.

Valid for: All regularly scheduled service on unlimited basis as to frequency. Pass to be show at each fare collection point.

That Weekly and Monthly passes local and express shall have Sunday Pass privileges as fares for a maximum of two (2) adults, 18 years of age or older.

FARE FOR RIDES OUTSIDE CUYAHOGA COUNTY

- (a) Rides wholly outside of Cuyahoga County ..... \$0.75
- (b) Through rides between Downtown Cleveland and:
  - Avon Lake (Lorain County) Route 31 ..... \$1.35
  - Willowick (Lake County) Route 43 ..... \$1.25
  - Wickliffe (Lake County) Route 49 ..... \$1.25
  - Brunswick (Medina County) Route 51 ..... \$1.45
- (c) Rides wholly within Cuyahoga County on the above lines shall be:
  - 1. Local Cash Fare ..... \$0.60
  - 2. Express Cash Fare ..... \$0.75
  - 3. Express Tickets.....Five (5) for..... \$3.75
  - 4. With Express Transfer ..... No Charge
  - 5. Fare with weekly, monthly or local pass, local fare ticket or transfer with connecting local lines, plus ..... \$0.15
  - 6. With Monthly Express Pass ..... No Charge

Section 3. That Resolutions 1975-84, adopted October 7, 1975; 1977-66, adopted February 22, 1977; 1979-134, adopted May 22, 1979; 1980-213, adopted June 3, 1980, be and they are hereby rescinded immediately.
