AUTHORIZING THREE SEPARATE CONTRACTS WITH WILSON BENNETT, INC.; RELIANCE MECHANICAL CORP.; AND ATLAS ELECTRIC COMPANY FOR PROJECT 5, CENTRAL RAIL MAINTENANCE FACILITY, RAIL DISTRICT HEADQUARTERS BUILDING, BID PACKAGE F-1, GENERAL TRADES, F-2 AND F-3, MECHANICAL AND PLUMBING AND F-4, ELECTRICAL, RESPECTIVELY (\$2,042,740 Capital Improvement Fund,\$1,542,740 OH-03-0054 and \$500,000 OH-03-0062)

BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bids of Wilson Bennett, Inc. and Reliance Mechanical Corp. received on December 7, 1982, for Project 5 - Central Rail Maintenance Facility, Rail District Headquarters Building, Bid Package F-1 General Trades, F-2 and F-3, Mechanical and Plumbing, respectively, at the prices set forth in said bids, involving a total expenditure of not to exceed One Million Six Hundred Sixty-Three Thousand and 00/100 Dollars (\$1,663,000), be and the same are hereby approved as the lowest and best responsible bids, and the General Manager of the Authority is herey authorized to enter into a contract with each bidder for the furnishing of said respective items.

Section 2. That the bid of the Atlas Electric Company received on December 7, 1982, for Project 5 - Central Rail Maintenance Facility, Rail District Head-quarters Building, Bid Package F-4 Electrical, at the prices set forth in said bid involving a total expenditure of not to exceed Three Hundred Seventy-Nine Thousand Seven Hundred Forty and 00/100 Dollars (\$379,740), be and the same is hereby approved as the lowest and best responsible bid, and the General Manager of the Authority is hereby authorized to enter into a contract with the bidder for the furnishing of said respective items.

Section 3. That said contracts shall provide for an expenditure of 80% UMTA funds.

Section 4. That said contracts shall be binding upon an obligation of the Authority contingent upon compliance by the contractors to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 1981-273; bonding, insurance requirements and all applicable laws relating to the contractual obligation of the Authority.

Section 5. That the contracts for Bid Package F-2 and F-3 shall be assigned to the contract for Bid Package F-1 in accordance with the bid documents.

Section 6. That the contract for Bid Package F-4 shall be assigned to the contract for Bid Package F-1 in accordance with the bid documents.

Section 7. That Sections 1, 3, 4 and 5 of this resolution shall become effective immediatey
