WHEREAS, the Greater Cleveland Regional Transit Authority, acting by Resolution No. 1982-323, adopted November 3, 1982, approved a Lease Agreement, including an Option to Purchase and terms thereof, the 10th and 11th floors (hereinafter "Premises") of the Frank J. Lausche State Office Building, between the Ohio Building Authority and the Greater Cleveland Regional Transit Authority; and

WHEREAS, the Greater Cleveland Regional Transit Authority, acting by Resolution No. 1982-324, adopted November 3, 1982, directed the President to exercise the aforesaid option, at a purchase price of Four Million Nine Hundred Three Thousand Three Hundred Sixty-Two Dollars (\$4,903,362.00), which was done with a closing date of June 30, 1983, or at an earlier date to be agreed upon by the parties; and

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority has been presented with schedules, exhibits and other related documents necessary to effectuate the transfer of the aforesaid premises to the Greater Cleveland Regional Transit Authority.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

That the President and the Secretary-Treasurer of the Authority be and they are hereby authorized to take such further action and to execute and deliver all such further agreements, instruments, certificates and documents, approved by the General Counsel, in the name of and on behalf of the Greater Cleveland Regional Transit Authority, as shall be necessary, proper or advisable in order to carry out the intent and to carry out the purposes of this Resolution.
