## RESOLUTION NO. 1983-173

AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE CITY OF CLEVELAND FOR THE DISBURSE-MENT OF FUNDS FROM GRANT NO. OH-23-9001 NOT TO EXCEED ONE MILLION FOUR HUNDRED SIXTY-EIGHT THOUSAND FOUR HUNDRED NINETY-FOUR DOLLARS (\$1,468,494.00) FOR THE REHABILITATION OF BRIDGES AT WEST SECOND, THIRD AND SIXTH STREETS

WHEREAS, the United States of America, Department of Transportation, throughs its Secretary, has approved a grant application made by the Greater Cleveland Regional Transit Authority entitled FFY 1982 - Tower City Grant Application, in the sum of Three Million One Hundred Fifty-Nine Thousand Nine Hundred Ninety-Four Dollars (\$3,159,994.00), representing eighty-five percent (85%) of the total estimated project cost; and

WHEREAS, said grant provides for the use of One Million Four Hundred Sixty-Eight Thousand Four Hundred Ninety-Four Dollars (\$1,468,494.00) of said grant for the rehabilitation of the bridges supporting West Second, Third and Sixth Streets; and

WHEREAS, the fifteen percent (15%) local share of project costs contemplated by said grant will be provided by the City of Cleveland from funds made available by UDAG Grant No. B-80-AA-39-0073 (as amended) and/or other sources; and

WHEREAS, the City of Cleveland has authorized its Directors of Economic Development and Public Service to enter a contract with the Greater Cleveland Regional Transit Authority for the partial funding of the rehabilitation of said bridges; and

WHEREAS, the Ohio Department of Transportation is preparing for the award of construction contracts in accordance with law, and must have the funding for construction and rehabilitation of said bridges in place by July 12, 1983, so that funds are obligated prior to the end of the current federal fiscal year.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Greater Cleveland Regional Transit Authority be and is hereby authorized to enter into and execute on behalf of the Greater Cleveland Regional Transit Authority an agreement with the

City of Cleveland, Ohio, to effectuate the rehabilitation of the bridges supporting West Second, Third and Sixth Streets at a cost to the Greater Cleveland Regional Transit Authority not to exceed One Million Four Hundred Sixty-Eight Thousand Four Hundred Ninety-Four Dollars (\$1,468,494.00), payable from UMTA Grant No. OH-23-9001.

Section 2. That said agreement shall provide that with respect to the rehabilitation of said bridges the City of Cleveland shall assume the obligations, certifications and requirements imposed upon the Greater Cleveland Regional Transit Authority as Grantee under UMTA Grant No. OH-23-9001.

Section 3. That said agreement shall require the City of Cleveland to provide all local match funding for the rehabilitation of the bridges supporting West Second, Third and Sixth Streets as described in UMTA Grant No. OH-23-9001, and shall require that all funds remaining in the City of Cleveland UDAG Grant fund after disbursement for the contemplated bridge repairs shall be reserved to the Greater Cleveland Regional Transit Authority for local match funding of all remaining projects under the said UMTA Grant.

 $\underline{\text{Section 4.}}$  That this resolution shall be effective immediately upon its adoption.
