AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH DELEUW, CATHER & COMPANY TO PROVIDE FOR AN EXTENSION OF TIME UNTIL DECEMBER 31, 1991, AND FOR AN INCREASE IN COST OF \$487,046.00 FOR A TOTAL EXPENDITURE NOT TO EXCEED \$4,188,662 (CAPITAL GRANT OH-03-0062)

WHEREAS, the Greater Cleveland Regional Transit Authority entered into a contract with DeLeuw, Cather & Company October 27, 1980, to provide A/E services for the Signal Rehabilitation Program, Project 12A, at a cost of Two Million, One Hundred Ninety Thousand, Six Hundred Sixty-One & 00/100 Dollars (\$2,190,661.00);

WHEREAS, said contract has been amended to increase the estimated cost under the contract to Three Million Seven Hundred One Thousand, Six Hundred Sixteen & 00/100 Dollars (\$3,701,616.00) and to extend its time for performance through May 31, 1991;

WHEREAS, to complete the signal rehabilitation under Project 12A, Bid Packages A, B, and C additional A/E services are required;

WHEREAS, the retention of DeLeuw, Cather & Company as the provider of the required A/E services is in the best interest of the Authority; and

WHEREAS, DeLeuw, Cather & Company has submitted a proposal to the authority providing for an increase in estimated cost of Four Hundred Eighty-Seven Thousand and Forty-Six & 00/100 Dollars (\$487,046.00) and an extension of the estimated time of completion to December 31, 1991.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to execute an amendment to the contract between the GCRTA and DeLeuw, Cather & Company to provide for an increase in expenditures not to exceed Four Hundred Eighty-Seven Thousand and Forty-Six & 00/100 Dollars (\$487,046.00) and an extension in time until December 31, 1991.

Section 2. That the contract as amended will provide for a total expenditure not to exceed Four Million, One Hundred Eighty-Eight Thousand, Sixty Hundred Sixty-Two & 00/100 Dollars (4,188,662.00) payable out of Capital Grant OH-03-0062.

Section 3. That all other provisions of the contract shall remain unchanged.

Section 4. That this resolution is effective immediately upon its adoption.
