

RESOLUTION NO. 1990-81

AUTHORIZING A CONTRACT WITH SOUTHEAST CHEVROLET COMPANY DBA, TONY LA RICHE CHEVROLET FOR THE FURNISHING OF SIXTEEN SUPERVISORY VEHICLES FOR A TOTAL PRICE OF \$183,594.72 (\$11,474.67 - CAPITAL GRANT OH-03-0062; \$11,474.67 - CAPITAL GRANT OH-05-0065; \$11,474.67 CAPITAL GRANT - OH-03-0054; \$149,170.71 RTA CAPITAL IMPROVEMENT FUND)

WHEREAS, the bid of Southeast Chevrolet Company, DBA Tony La Riche Chevrolet located at 2810 Bishop Road, Willoughby, Ohio 44143 for the furnishing of sixteen supervisory vehicles was received on the 23rd day of April, 1990, for the price set forth in said bid, involving an expenditure of one hundred eighty three thousand five hundred ninety-four & 72/100 dollars (\$183,594.72); and

WHEREAS, the General Manager deems the bid of Southeast Chevrolet Company, DBA Tony La Riche Chevrolet to be the lowest and best responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Southeast Chevrolet Company, DBA Tony La Riche Chevrolet for the furnishing of sixteen supervisory vehicles at a price of one hundred eighty three thousand five hundred ninety-four & 72/100 dollars (\$183,594.72) be and the same is hereby accepted as the lowest and best responsive bid from a responsible bidder.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Southeast Chevrolet Company DBA, Tony La Riche Chevrolet for the furnishing of sixteen supervisory vehicles.

Section 3. That said contract shall be payable out of Capital Improvement Fund in the amount of one hundred forty nine thousand one hundred seventy & 71/100 dollars (\$149,170.71), Support Services Budget; eleven thousand four hundred seventy four & 67/100 dollars (\$11,474.67) Capital Grant OH-03-0062, eleven thousand four hundred seventy four & 67/100 dollars (\$11,474.67) Capital Grant OH-05-0065, eleven thousand four hundred seventy four & 67/100 dollars (11,474.67) Capital Grant OH-03-0054.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon appropriations for future contract years and upon compliance by the contractor to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
