DECLARING AN EMERGENCY RELATING TO THE PROVISION OF TRANSPORTATION FOR THE ELDERLY AND HANDICAPPED IN THE SUBURBS AND AWARDING CONTRACTS TO HOPKINS LIMOUSINE SERVICE (EST. \$25,000.00), PROVIDE-A-RIDE (EST. \$25,000.00), BUTLER EXPRESS (EST. \$25,000.00), MR. C. CHARTER SERVICE (EST. \$25,000.00), SPECIAL BUSING (EST. \$25,000.00), AND PHYSICIANS AMBULANCE SERVICE (EST. \$25,000.00) - TOTAL EST. \$150,000 - GENERAL FUND - COMMUNITY RESPONSIVE TRANSIT BUDGET.

WHEREAS, the General Manager informed the Board of Trustees of the Greater Cleveland Regional Transit Authority that it was necessary to implement an emergency program to provide transportation for the elderly and handicapped in the suburbs;

WHEREAS, to provide this service it is necessary to enter into six (6) individual contracts to provide this service on an emergency basis; and

WHEREAS, these firms are: (1) Hopkins Limousine Service, (2) Provide-A-Ride, (3) Butler Express, (4) Mr. C. Charter Service, (5) Special Busing, and (6) Physicians Ambulance Service.

Now, therefore, be it resolved by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That a real and present emergency exists within the meaning of O.R.C., Section 306.43.

Section 2. That the General Manager is authorized to enter into contracts with (1) Hopkins Limousine Service, (2) Provide-A-Ride, (3) Butler Express, (4) Mr. C. Charter Service, (5) Special Busing, and (6) Physicians Ambulance Service.

Section 3. That the total of each contract shall not exceed twenty-five thousand & 00/100 (\$25,000.00).

Section 4. That said emergency contracts shall be payable from the General Fund.

Section 5. That said resolutions shall become effective immediately upon its adoption.
