

RESOLUTION NO. 1991 - 24

**A RESOLUTION FIXING THE RATES OF FARES
TO BE CHARGED ON THE GREATER CLEVELAND
REGIONAL TRANSIT AUTHORITY**

BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That effective February 17, 1991, for the Greater Cleveland Regional Transit Authority, local fares shall be increased fifteen cents (\$.15), express fares shall be increased twenty-five cents (\$.25), and fares for senior citizens, handicapped persons, and downtown loop services shall be increased ten cents (\$.10).

Section 2. That the Rate of Fares to be charged on the Greater Cleveland Regional Transit Authority are hereby fixed as follows:

CHILDREN'S FARES

Up to three children under six (6) years of age may ride free when accompanied by an adult paying full fare.

MISCELLANEOUS FARES

Greater Cleveland Regional Transit Authority Trustees, employees and Pensioners with I.D. cards, and all duly appointed, regular, full-time, Municipal and/or County police, fire, and law enforcement officers in uniform or upon showing their official badge and proper identification are permitted to ride free.


(c) Fares for rides wholly within Cuyahoga County on the above lines shall be the same as outlined in previous sections.

Section 3. That all other fares or special fare media now in use shall remain set at current levels.

Section 4. That Resolution 1982-156 adopted May 30, 1982 be and it is hereby rescinded, effective January 22, 1991.

Section 5. That this Resolution shall become effective immediately upon its adoption.
