

RESOLUTION NO. 1991-70

AUTHORIZING CONTRACTS WITH WABCO PASSENGER TRANSIT DIVISION FOR \$6,474.50, HALL INDUSTRIES FOR \$41,007.90 AND UNITED KNITTING MACHINE FOR \$10,781.69 FOR THE FURNISHING OF TRANSIT COUPLER PARTS AS REQUIRED FOR A PERIOD OF ONE (1) YEAR (TOTAL ESTIMATED EXPENDITURE \$58,264.09 - GENERAL FUND) INVENTORY DEPARTMENT BUDGET.

WHEREAS, the divisible bids of WABCO Passenger Transit Division located at P.O. Box 11, Spartanburg, South Carolina 29304-0011; Hall Industries, Inc. located at 201 East Carson Street, Pittsburgh, Pennsylvania 15219 and United Knitting Machine Company, Inc. located at Gehman Road and Transit Way, Kulpsville, Pennsylvania 19443 for the furnishing of transit coupler parts, as required, was received on the 22nd of March 1991, for the price set forth in said bids, involving a total estimated expenditure of fifty-eight thousand two hundred sixty-four & 09/100 dollars (\$58,264.09);

WHEREAS, the General Manager deems the bid of WABCO Transit Division for twenty three (23) items; Hall Industries, Inc. for sixty-three (63) items; and United Knitting Machine Company, Inc. for nine (9) items to be the lowest and best responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of WABCO Passenger Transit Division of Westinghouse, the bid of Hall Industries, Inc. with WABCO Passenger Transit Division of Westinghouse Air Brake (for items 8, 15, 17, 18, 28, 29, 30, 31, 42, 43, 50, 51, 56, 81, 82, 83, 86, 87, 90, 91, 96, 125, 136) the bid of Hall Industries, Inc. (for items 3, 4, 5, 9, 12, 13, 22, 23, 26, 33, 34, 36, 37, 39, 40, 44, 45, 46, 49, 58, 60, 63, 64, 67, 72, 73, 74, 75, 76, 77, 78, 80, 84, 89, 99, 101, 102, 103, 104, 107, 109, 110, 111, 112, 114, 115, 117, 119, 121, 123, 124, 127, 128, 131, 134, 135, 143, 145, 147, 149, 152, 153, 154) and the bid of United Knitting Machine Company, Inc. (for items 21, 24, 25, 38, 61, 126, 130, 146, 148) be and the same are hereby accepted as the lowest responsive divisible bids from responsible bidders.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into contracts with WABCO Passenger Transit Division for six thousand four hundred seventy-four & 50/100 dollars (\$6,474.50), Hall Industries for forty-one thousand seven & 90/100 dollars (\$41,007.90) and United Knitting Machine Company, Inc. for ten thousand seven hundred eighty-one & 69/100 dollars (\$10,781.69).

Section 3. That said contract shall be payable out of the General Fund in a estimated total expenditure not to exceed fifty-eight thousand two hundred sixty-four & 09/100 dollars (\$58,264.09).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Bid Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
