## RESOLUTION NO. 1991-71

AUTHORIZING A CONTRACT WITH WABCO PASSENGER TRANSIT DIVISION OF WESTINGHOUSE AIR BRAKE COMPANY, FOR THE FURNISHING OF TRANSIT COUPLER PARTS AVAILABLE ONLY FROM THE ORIGINAL EQUIPMENT MANUFACTURER FOR A ONE (1) YEAR PERIOD, ON AN AS REQUIRED BASIS, AT A TOTAL PRICE OF \$37,581.45 (INVENTORY DEPARTMENT BUDGET).

WHEREAS, the required coupler parts were advertised for bid in accordance with Ohio Revised Code 306.43(b);

WHEREAS, after receipt of bids, certain items in the solicitation were found to be available only from WABCO Passenger Transit Division, the original equipment manufacturer, located at P.O. Box 11, Spartanburg, S.C. 29304-0011, competition was deemed inadequate, as no other bidder submitted bids for these items; and

WHEREAS, the Ohio Revised Code 306.43(b) provides that competitive bidding is not required when a purchase consists of replacement parts for equipment owned or leased by the Regional Transit Authority and the only source of supply for such parts is limited to a single supplier.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with WABCO Passenger Transit Division of Westinghouse Air Brake Company, for the furnishing of transit coupler parts, available only from the original equipment manufacturer, for a period of one (1) year.

Section 2. That said contract shall be payable out of the General Fund in the total amount of thirty-seven thousand five hundred eighty-one & 45/100 dollars (\$37,581.45).

Section 3. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 4. That this resolution shall become effective immediately upon its adoption.
