

RESOLUTION NO. 1991- 97

AUTHORIZING CONTRACTS WITH WOOSTER IRON & METAL, PROGRESSIVE BULK SYSTEMS, D&D TRUCKING, STEVE NEBEHAY, LINDA REUBEN, ANNIE BLAINNEY, ROBIN WASHINGTON, NORTHERN OHIO RAILWAY MUSEUM, JOHN HINKEL AND EDITH MCKEE FOR THE SALE OF THIRTY-SIX (36) SCRAP COACHES, THIRTEEN (13) SCRAP CARS, ONE (1) SCRAP CRT VEHICLE, THREE (3) SCRAP TRUCKS, AND TWELVE (12) SCRAP DIESEL ENGINE BLOCKS.

WHEREAS, coach numbers 151, 216, 2502, 2503, 2505, 2512, 2525, 2553, 2567, 2569, 2570, 2574, 2603, 2605, 2615, 2623, 2640, 7551, 2504, 2519, 2534, 2538, 2551, 2566, 2575, 2599, 2602, 2604, 2616, 2622, 2627, 2629, 2633, 2638, 2642, 2647 and car numbers T-19, E-23, R-46, R-47, E-51, E-52, O-53, E-54, E-63, 960, 961, 964, 983 and CRT vehicle number 9513 and Truck numbers R-120, P-146, P-147 and three (3) 6V71 diesel engine blocks and nine (9) 8V71 diesel engine blocks have been determined obsolete in accordance with the Authority's scrap policy; and

WHEREAS, the bids of Wooster Iron & Metal, Progressive Bulk Supply Systems, D&D Trucking, Steve Nebhay, Linda Reuben, Annie Blainey, Robin Washington, Northern Ohio Railway Museum, John Hinkel and Edith McKee were received on the 30th day of April 1991 for a total sales price of twenty-nine thousand fifty-five & 60/100 dollars (\$29,055.60);

WHEREAS, the General Manager deems these bids to be the highest responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bids of Wooster Iron & Metal, Progressive Bulk Systems, D&D Trucking, Steve Nebhay, Linda Reuben, Annie Blainey, Robin Washington, Northern Ohio Railway Museum, John Hinkel, Edith McKee as listed below be and the same is hereby accepted as the highest responsive bids from responsible bidders.

Wooster Iron & Metal for the sale of coach numbers 151, 216, 2502, 2503, 2505, 2512, 2570, 2615, 2640, 2519, 2599, 2602, 2604, 2622 and three (3) 6V71 diesel blocks and nine (9) 8V71 diesel blocks for a total purchase price of thirteen thousand seven hundred forty-eight & 60/100 (\$13,748.60).

Progressive Bulk Systems for the sale of coach numbers 2525, 2553, 2567, 2569, 2574, 2603, 2605, 2623, 7551, 2504, 2534, 2538, 2551, 2566, 2575, 2616, 2627, 2629, 2633, 2638, 2642 and 2647 for a total purchase price of six thousand seven hundred ten & 00/100 dollars (\$6,710.00).

D&D Trucking for the sale of vehicle numbers E-23, E-52, 960, 961, 964, 9513, 983, P-146 and P-147 for a total purchase price of four thousand two hundred seventy-four & 00/100 dollars (\$4,274.00).

Steve Nebhay for the sale of vehicle numbers R-46 and E-51 for a total purchase price of one thousand four hundred & 00/100 dollars (\$1,400.00).

Linda Reuben for the sale of vehicle number O-53 for a total purchase price of seven hundred five & 00/100 dollars (\$705.00).

Annie Blainey for the sale of vehicle number E-54 for a total purchase price of six hundred ninety-two & 00/100 dollars (\$692.00).

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into contracts with said companies for the sale of said property as described on such terms as are appropriate for the protection of the interests of the Authority.

Section 3. That the proceeds of said sales, twenty-nine thousand fifty-five & 60/100 dollars (\$29,055.60) be deposited into the General Fund.
