AUTHORIZING CONTRACTS WITH WOOSTER IRON & METAL, CO., MARGARET BENO, EDITH MCKEE, TED POMPEI, LAMONT PERRY AND PROGRESSIVE BULK SYSTEMS FOR THE SALE OF NINE (9) SCRAP VEHICLES

WHEREAS, Vehicle No's E-23, E-52, 960, 961, 964, 9513, 983, P-146 and P-147 have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, the high bidder D&D Trucking, Inc. has defaulted on the purchase of these nine (9) vehicles and the award rescinded; and

WHEREAS, the second highest bidders have agreed to the purchase . of these nine (9) scrap vehicles at their original bid prices; and

WHEREAS, the bids of Wooster Iron & Metal Co., Margaret Beno, Edith McKee, Ted Pompei, Lamont Perry and Progressive Bulk Systems were received on the 30th day of April, 1991 for a total sales price of two thousand one hundred eighty-one & 22/100 dollars (\$2,181.22);

WHEREAS, the General Manager deems the bids of Wooster Iron & Metal Co., Margaret Beno, Edith McKee, Ted Pompei, Lamont Perry and Progressive Bulk Systems to be the highest responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

Wooster Iron & Metal Co. for the sale of vehicle number 9513 for the purchase price of twenty-two & 22/100 dollars (\$22.22).

Margaret Beno for the sale of vehicle number E-23 for the purchase price of three hundred & 00/100 dollars (\$300.00).

Edith McKee for the sale of vehicles E-52 & R-146 for the total purchase price of seven hundred six & 00/100 (\$706.00).

Ted Pompei for the sale of vehicles 960, 961, 964 for the total purchase price of eight hundred seventy-eight & 00/100 dollars (\$878.00).

Lamont Perry for the sale of vehicle 983 for the total purchase price of twenty-five & 00/100 dollars (\$25.00).

Progressive Bulk Systems for the sale of vehicle P-147 for the total purchase price of two hundred fifty & 00/100 dollars (\$250.00).
