

RESOLUTION NO. 1991- 178

AUTHORIZING CONTRACTS WITH MILLAR ELEVATOR SERVICE COMPANY FOR THE FURNISHING OF ESCALATOR MAINTENANCE SERVICES AT RED LINE STATIONS AND WITH GENERAL ELEVATOR COMPANY, INC. FOR ELEVATOR MAINTENANCE SERVICES AT THE AUTHORITY'S MAINTENANCE FACILITIES FOR A PERIOD OF FIVE (5) YEARS (EST. \$293,580.00 - GENERAL FUND) - FACILITIES MAINTENANCE DEPARTMENT BUDGET.

WHEREAS, the bid of the Millar Elevator Service Company, located at 1100 East 55th Street, Cleveland, Ohio 44103, for the furnishing of escalator maintenance services at Red Line Stations and the bid of General Elevator Company, located at 668 Euclid Avenue, Cleveland, Ohio 44114, for the furnishing of elevator maintenance services at the Authority's Maintenance Facilities, were received on the 9th day of September, 1991, for the price set forth in said bids, involving an estimated expenditure of two hundred ninety-three thousand five hundred eighty & 00/100 dollars (\$293,580.00); and

WHEREAS, the General Manager deems the bid of the Millar Elevator Service Company and General Elevator Company, Inc., respectively, to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of the Millar Elevator Service Company, for escalator maintenance services at the Authority's Red Line Rapid Transit Stations, be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with the Millar Elevator Service Company for the furnishing of escalator maintenance services for a period of five (5) years.

Section 3. That said contract shall be payable out of the General Fund in an estimated amount not to exceed two hundred sixty-eight thousand three hundred eighty & 00/100 dollars (\$268,380.00).

Section 4. That the bid of the General Elevator Company, Inc. for elevator maintenance services at the Authority's maintenance facilities, be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.


Section 5. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with the General Elevator Company, Inc. for elevator maintenance services at the Authority's maintenance facilities for a period of five (5) years.

Section 6. That said contract shall be payable out of the General Fund in an estimated amount not to exceed twenty-five thousand two hundred & 00/100 dollars (\$25,200.00).


Section 7. That said contracts shall be binding upon and an obligation of the Authority contingent upon appropriations for future contract years and upon compliance by the contractor to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 8. That this resolution shall become effective immediately upon its adoption.
