AUTHORIZING AN AMENDMENT TO CONTRACT RC 90086 WITH SAFETY KLEEN CORPORATION FOR THE PERIODIC SOLVENT REPLACEMENT AND PARTS WASH TANK CLEANING SERVICE AUTHORITY-WIDE, TO PROVIDE AN INCREASE IN THE CONTRACT PRICE IN AN AMOUNT NOT TO EXCEED \$11,700.00 (GENERAL FUND) - BUS EQUIPMENT DEPARTMENT BUDGET.

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority, by Resolution NO. 1990-176, authorized Contract RC 90086 with Safety Kleen Corporation to provide the Authority's requirements for periodic solvent replacement and parts wash tank cleaning service for a one (1) year period, ending November 14, 1991, at an estimated price of ninety-eight thousand two hundred thirty-seven & 25/100 dollars (\$98,237.25);

WHEREAS, the General Manager has previously exercised the authority granted him by the Board of Trustees and increased the contract to one hundred three thousand five hundred thirty-seven & 25/100 dollars (\$103.537.25) allowing service to commence at the reopened Brooklyn Garage;

WHEREAS, the expiration date was also extended to December 31, 1991 by the General Manager to allow sufficient time to properly conduct sealed bidding procedures culminating in award of a continuing contract for this service; and

WHEREAS, this additional service interval will require the additional expenditure of eleven thousand seven hundred & 00/100 dollars (\$11,700.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to amend the contract with Safety Kleen Corporation for the periodic solvent replacement and parts wash tank cleaning service by increasing the contract price by an amount not to exceed eleven thousand seven hundred & 00/100 dollars (\$11,700.00) to a total contract amount of one hundred fifteen thousand two hundred thirty-seven & 25/100 dollars (\$115,237.25).

Section 2. That this amendment shall be payable out of the General Fund (Bus Equipment Department budget, Line Item 503.051 Service).

Section 3. That all other conditions and provisions of the contract shall remain the same.
