## **RESOLUTION NO. 1991-249**

AUTHORIZING A CONTRACT EXTENSION WITH AREA TEMPS, INC., FOR THE PERSONAL SERVICES OF ZOLA KOBUS TO PROVIDE STRUCTURAL QUALITY ASSURANCE SERVICES FOR CAPITAL CONSTRUCTION PROJECTS FOR THE PERIOD FROM JANUARY 1, 1992, THROUGH MARCH 31, 1992 (EST. \$15,000 - GENERAL FUND) - ENGINEERING AND CONSTRUCTION DEPARTMENT BUDGET

WHEREAS, the Greater Cleveland Regional Transit Authority is required to provide quality assurance oversight functions for capital construction projects;

WHEREAS, a personal services contract with Area Temps, Inc., for the services of Zola Kobus to perform construction quality assurance duties was executed under the General Manager's procurement authority on January 2, 1991, for the period January 2, 1991 through May 16, 1991, and extended through December 31, 1991, by resolution No. 1991-58;

WHEREAS, the continued services of Zola Kobus to provide quality assurance oversight functions on capital construction projects are required through March 31, 1992;

WHEREAS, the additional services are estimated to require a fifteen thousand dollars (\$15,000) increase to the total contract amount; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

- Section 1. That the General Manager of the Authority be and he is hereby authorized to extend the contract with Area Temps, Inc., to provide the personal services of Zola F. Kobus for quality assurance services for the period from January 1, 1992, through March 31, 1992.
- Section 2. That Area Temps, Inc., shall be compensated at the rate of twenty-eight dollars and fifty-eight cents (\$28.58) per hour, not to exceed the total sum of fifteen thousand dollars (\$15,000.00).
- $\frac{\text{Section 3.}}{\text{hundred dollars ($73,500.00)}}.$  That the total contract shall not exceed seventy-three thousand
- <u>Section 4.</u> That said contract shall be payable out of the Engineering and Construction Department budget.
- <u>Section 5.</u> That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by Area Temps, Inc., and Zola Kobus with the terms of the contract and all applicable laws relating to the contractual obligations of the Authority.
