

**A RESOLUTION ESTABLISHING AN ARTS IN TRANSIT COMMITTEE  
AND APPOINTING MEMBERS TO THE COMMITTEE**

WHEREAS, the Greater Cleveland Regional Transit Authority recognizes the need to provide public transit service which provides a contribution to the neighborhoods of Greater Cleveland and the community as a whole; and

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority on August 20, 1991 adopted Policies and Procedures for administering an Arts in Transit Program; and

WHEREAS, the Policies and Procedures directed the General Manager/Secretary Treasurer to organize an Arts in Transit Committee consisting of a cross section of Cleveland area residents with interest and expertise in the arts and humanities; and

WHEREAS, the General Manager/Secretary Treasurer is authorized by the Policies and Procedures to select the membership of the Arts in Transit committee for approval by the Board of Trustees of the Greater Cleveland Regional Transit Authority;

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority;

SECTION 1: That an Arts in Transit Committee be established within the organization of the Greater Cleveland Regional Transit Authority; and

SECTION 2: That the individuals named on the list attached hereto as Attachment A and incorporated as reference herein be appointed members of the Greater Cleveland Regional Transit Authority Arts in Transit Committee; and

SECTION 3: That their membership take effect immediately upon appointment by the Board of Trustees.
