

RESOLUTION NO. 1992- 23

AUTHORIZING AN AMENDMENT TO CONTRACT C-89053 WITH COYNE TEXTILE SERVICES FOR THE FURNISHING OF SHOP GARMENTS FOR THE PERIOD ENDING DECEMBER 31, 1992, TO PROVIDE AN INCREASE IN THE CONTRACT PRICE IN AN AMOUNT NOT TO EXCEED \$180,000.00 (GENERAL FUND) - FRINGE BENEFIT ACCOUNT.

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority, by Resolution 1989-72, authorized Contract C-89053 with Coyne Textile Services to provide the Authority's requirements for the furnishing and weekly cleaning of shop garments for a three and one-half (3-1/2) year period, ending December 31, 1992, at an estimated price of five hundred twenty-eight thousand nine hundred sixty-nine & 00/100 dollars (\$528,969.00);

WHEREAS, award was made based on an estimated number of employees being provided with polyester/cotton uniforms;

WHEREAS, during the contract period the number of employees entitled to this uniform service increased by twenty-two percent (22%);

WHEREAS, approximately twenty-three percent (23%) of the maintenance positions were found to require the added safety realized by one hundred percent (100%) cotton uniforms;

WHEREAS, the additional employees utilizing this uniform service and the percentage requiring the more expensive cotton uniforms could not have been anticipated; and

WHEREAS, this additional service will require the estimated additional expenditure of one hundred eighty thousand & 00/100 dollars (\$180,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to amend the contract with Coyne Textile Services for the furnishing and weekly cleaning of shop garments by increasing the contract price by an amount not to exceed one hundred eighty thousand & 00/100 dollars (\$180,000.00) to a total contract amount of seven hundred forty-eight thousand nine hundred sixty-nine & 00/100 dollars (\$748,969.00).


Section 2. That this amendment shall be payable out of the General Fund (Fringe Benefit Account, Line Item 502.132).

Section 3. That all other conditions and provisions of the contract remain the same.


Section 4. That this resolution shall become effective immediately upon its adoption.
