

RESOLUTION 1992-98

AUTHORIZING A CONTRACT WITH VEHICLE MAINTENANCE PROGRAM FOR THE FURNISHING OF MOTOR COACH FILTERS, AS REQUIRED FOR A PERIOD OF ONE (1) YEAR FOR AN ESTIMATED EXPENDITURE OF \$63,680.00 (GENERAL FUND, INVENTORY DEPARTMENT BUDGET).

WHEREAS, the bid of Vehicle Maintenance Program located at 622 Hungerford Dr., Suite #5, Rockville, MD 20850, for the furnishing of motor coach filters, as required, was received on the 25th day of June, 1992, for the prices set forth in said bid involving an estimated expenditure of sixty-three thousand six hundred eighty & 00/100 dollars (\$63,680.00); and

WHEREAS, this procurement is divisible;

WHEREAS, the General Manager deems the bid of Vehicle Maintenance Program for Items 5 (GCRTA No. 81-20001-FRAM), 6 (GCRTA No. 81-20002-FRAM), 8 (GCRTA No. 87-10-FRAM) and 11 (GCRTA NO. 87-23127-FRAM) of IFB No. 92063 to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Vehicle Maintenance Program for Items 5, 6, 8 and 11 of IFB No. 92063 be and the same is hereby accepted as the lowest responsive and responsible bid.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Vehicle Maintenance Program for the furnishing of motor coach filters, as required for a period of one (1) year.


Section 3. That said contract shall be payable out of the General Fund, (Inventory Department Budget) in an estimated amount not to exceed sixty-three thousand six hundred eighty & 00/100 dollars (\$63,680.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.
