

RESOLUTION NO. 1992 - 132

COMMENDING JIMMIE TOLBERT FOR WINNING THE 1992 GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY BUS ROADEO, AND REPRESENTING THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY IN THE 1992 OHIO PUBLIC TRANSIT ASSOCIATION/OHIO DEPARTMENT OF TRANSPORTATION STATE BUS ROADEO HELD IN CLEVELAND, OHIO, AND THE 1992 INTERNATIONAL BUS ROADEO HELD IN SAN DIEGO, CALIFORNIA

WHEREAS, Jimmie Tolbert, Bus Operator from Triskett District, was the winner in the 1992 Greater Cleveland Regional Transit Authority Bus Roadeo in which fifty-one (51) Bus Operators representing various districts competed; and

WHEREAS, Jimmie Tolbert took First Place honors, for the fifth consecutive year, in the 1992 Greater Cleveland Regional Transit Authority Bus Roadeo against the best Bus Operators from GCRTA; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County:

Section 1. That Jimmie Tolbert, Bus Operator from Triskett District, be and is hereby commended for winning the 1992 Greater Cleveland Regional Transit Authority Bus Roadeo Competition.

Section 2. That Jimmie Tolbert is commended for representing the Greater Cleveland Regional Transit Authority in State competition in the 1992 Ohio Public Transit Association/Ohio Department of Transportation State Bus Roadeo held in Cleveland, Ohio.


Section 3. That Jimmie Tolbert is further commended for representing the Greater Cleveland Regional Transit Authority in the 1992 International Bus Roadeo held in San Diego, California.
