

RESOLUTION NO. 1992-226

**AUTHORIZING A CONTRACT WITH SAINT ALEXIS HOSPITAL MEDICAL CENTER TO PROVIDE EMPLOYMENT RELATED MEDICAL SERVICES TO THE GCRTA FOR A PERIOD COMMENCING ON JANUARY 1, 1993 TO JANUARY 1, 1995 FOR AN AMOUNT NOT TO EXCEED \$260,000.00 (GENERAL FUND - PERSONNEL ADMINISTRATION DEPARTMENT BUDGET)**

WHEREAS, the Greater Cleveland Regional Transit Authority requires the services of a medical provider for its employment related medical services; and

WHEREAS, Saint Alexis Hospital Medical Center located at 5163 Broadway Avenue, Cleveland, Ohio 44127 has offered to provide these services for the period commencing January 1, 1993 to January 1, 1995; and

WHEREAS, the General Manager deems the offer of Saint Alexis Hospital Medical Center, as modified through negotiations, to be the most advantageous to the Authority, and the estimated cost of two hundred sixty thousand & 00/100 (\$260,000.00) to be fair and reasonable and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the best and final offer submitted by Saint Alexis Hospital Medical Center, in accordance with its response to the request for proposal and as a result of negotiations, be and it is hereby accepted.

Section 2. That the General Manager be and he is hereby authorized to enter into a contract with Saint Alexis Hospital Medical Center for the provision of employment-related medical services.

Section 3. That Saint Alexis Hospital Medical Center be compensated in an amount not to exceed two hundred sixty thousand & 00/100 dollars (\$260,000.00) for a period commencing on January 1, 1993 to January 1, 1995 at the negotiated rates set forth in said contract.

Section 4. That said amount shall be payable out of the General Fund (Personnel Administration Department).



That said contract shall be binding upon and an obligation of the Authority contingent upon appropriations for future contract years and upon compliance by the contractor to the Statement of Work and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements; and all applicable laws relating to the contractual obligations of the Authority.
