

RESOLUTION NO. 1993-152

AN AMENDMENT TO CONTRACT 93024 WITH DOMINIC CALABRESE CEMENT CONTRACTORS, INC. TO PROVIDE REHABILITATION OF THE BUS LOOP AT E. 131ST STREET AT MILES IN AN AMOUNT NOT TO EXCEED (\$38,789.00) CAPITAL GRANT OH-90-X179 (\$31,031.20 IN FEDERAL FUNDS WHICH REPRESENTS 80% OF THE TOTAL)

WHEREAS, the Board of Trustees by Resolution No. 1993-75 authorized Contract No. 93024 with Dominic Calabrese Cement Contractors, Inc. for the provision of work to rehabilitate the Bus Loops at (18D) E. 131st Street/Miles and (18E) E. 159th Street/Kinsman (Chagrin Boulevard); and

WHEREAS, the Board of Trustees by Resolution No. 1993-98 modified the scope of work for the contract by eliminating the (18E) E. 159th Street/Kinsman (Chagrin Boulevard) portion of the contract; and

WHEREAS, the specifications for (18D), E. 131st Street/Miles, includes provisions for the use of Alternates G-2, G-4, G-6, and E-1, at a price of \$38,789.00; and

WHEREAS, the General Manager has determined that it is in the best interest of the Authority to utilize the specified alternates at the bid prices.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Authority be and he is hereby authorized to amend contract No. 93024 with Dominic Calabrese Cement Contractors, Inc. for the furnishing of Alternates G-2, G-4, G-6, and E-1 in an amount not to exceed thirty-eight thousand seven hundred eighty nine & 00/100 dollars (\$38,789.00).

Section 2. That said change shall be payable out of Capital Grant OH-90-X179 in an amount not to exceed thirty eight thousand seven hundred eighty nine & 00/100 dollars (\$38,789.00).

Section 3. That said contract shall be binding upon and an obligation of the Authority contingent upon appropriations for future contract years and upon compliance by the contractor to the Bid Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1985-87; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 4. That this resolution shall become effective immediately upon its adoption.
