RESOLUTION NO. 1993 -163

AUTHORIZING A CONTRACT WITH MULTISYSTEMS, INCORPORATED FOR THE FURNISHING AND INSTALLATION OF COMPUTER SOFTWARE AND HARDWARE TO PROVIDE AN AUTOMATED CUSTOMER INFORMATION SYSTEM AND AMERICANS WITH DISABILITIES ACT RELATED SYSTEM AT A TOTAL PRICE NOT TO EXCEED \$1,169,918.00 (\$877,438.50 IN FEDERAL FUNDS WHICH REPRESENTS 75% OF THE TOTAL COST) - CAPITAL GRANT OH-03-0113.

WHEREAS, the proposal of Multisystems, Incorporated, located at 1050 Massachusetts Avenue, Cambridge, MA 02138-5381, for the development and installation of an integrated customer information system, geographic information system and paratransit scheduling system, compliant with the Americans with Disabilities Act was received on April 30, 1993; and

WHEREAS, negotiations concluded with a mutual understanding of the scope of work, involving an agreed upon price not to exceed one million one hundred sixty-nine thousand nine hundred eighteen & 00/100 dollars (\$1,169,918.00); and

WHEREAS, the General Manager deems the proposal of Multisystems, Incorporated to be the most advantageous to this Authority, finds the negotiated priced be fair and reasonable, and therefore, recommends the same for acceptance by the Greater Cleveland Regional Transit Authority Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the negotiated proposal of Multisystems, Incorporated be and the same is hereby accepted as the most advantageous to this Authority, price and other factors considered.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Multisystems, Incorporated for the development and installation of an integrated customer information system, geographic information system and paratransit scheduling system, compliant with the Americans with Disabilities Act consistent with the terms and conditions of the Request for Proposal and the negotiated proposal of Multisystems, Incorporated.

Section 3. That said contract shall be payable out of Capital Grant 0H-03-0113 in an amount not to exceed one million one hundred sixty-nine thousand nine hundred eighteen & 00/100 dollars (\$1,169,918.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Scope of Work and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements, and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
