## **RESOLUTION NO. 1993-** 169

AUTHORIZING A CHANGE ORDER TO THE CONTRACT WITH URS CONSULTANTS, INC. FOR THE DESIGN OF THE GCRTA PASSENGER ACCESSWAY TO GATEWAY IN THE AMOUNT OF \$103,360.00, CAPITAL GRANT OH-90-X170 \$52,900.00 (\$47,081.00 IN FEDERAL FUNDS WHICH REPRESENTS APPROXIMATELY 46% OF THE TOTAL) AND \$50,460.00 IN LOCAL MATCH

WHEREAS, the Board of Trustees, by Resolution No. 1992-193 authorized a contract with URS Consultants, Inc. for the design and engineering of the GCRTA Passenger Accessway connecting the Tower City Rapid Station to the Gateway Arena and Sports Complex at an estimated cost of three hundred thousand & 00/100 dollars (\$300,000.00); and

WHEREAS, the Board of Trustees by Resolution 1993-71 authorized additional design and engineering services to accommodate needed zoning and safety required changes; and

WHEREAS, unforeseen site conditions have arisen during the actual construction which require design and engineering changes to ensure safety, structural integrity and schedule integrity; and

WHEREAS, the cost of the additional services is estimated at one hundred three thousand three hundred sixty & 00/100 dollars (\$103,360.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to modify the contract with URS Consultants, Inc. to include the additional services necessary for the design and engineering services required during the construction of the Greater Cleveland Regional Transit Authority Passenger Accessway connecting the Tower City Rapid Station to the Gateway Arena and Sports Complex.

Section 2. That the General Manager be and he is hereby authorized to increase the price of the contract with URS Consultants, Inc. by one hundred three thousand three hundred sixty & 00/100 dollars (\$103,360.00) to a maximum total price of six hundred sixty-seven thousand one hundred three and 00/100 dollars (\$667,103.00).

Section 3. That the General Manager's Change Order authority, pursuant to Section I-4.2.7.2 of the Greater Cleveland Regional Transit Authority Procurement Policy, is reauthorized.

Section 4. That this contract amendment shall be payable out of Capital Grant OH-90-X170 and Local Match.

Section 6. That this resolution shall become effective immediately upon its adoption.
