RESOLUTION NO. 1993-186

AUTHORIZING A CHANGE ORDER TO THE CONTRACT WITH URS CONSULTANTS, INC. FOR PROJECT 27A & B - DESIGN AND ENGINEERING SERVICES FOR THE REHABILITATION OF THE 75TH AND 79TH STREET BRIDGES IN THE AMOUNT OF \$12,829.00 (\$10,263.20 IN FEDERAL FUNDS WHICH REPRESENTS 80% OF THE TOTAL COST) - CAPITAL GRANT OH-03-0054.

WHEREAS, the Board of Trustees, by Resolution No. 1990-227 authorized a contract with URS Consultants, Inc., Bridge Design Division, at 3605 Warrensville Center Road, Cleveland, Ohio 44122 in the amount of two hundred thirty-eight thousand & 00/100 dollars (\$238,000.00) for the design services which would result in the rehabilitation of the E. 75th and E. 79th Street bridges and extend their useful life approximately twenty-five (25) years; and

WHEREAS, in 1992 the Ohio Department of Transportation (ODOT) and the Greater Cleveland Regional Transit Authority (Authority) entered into a bridge rehabilitation and construction program which provides that ODOT shall perform the actual bidding and management of bridge construction program and the Authority would provide the architectural and engineering services; and

WHEREAS, under the program ODOT has required the continued services of the Authority's architectural and design contractor through the completion of the construction and final rehabilitation of the E. 75th and E.79th Street bridges; and

WHEREAS, as a program requirement the Authority has agreed to pay for the cost of its design services through the completion of the construction/rehabilitation stage; and

WHEREAS, the General Manager, pursuant to the authority under the GCRTA <u>Procurement Policy Manual</u> authorized a change to the above contract in the amount of fourteen thousand eight hundred & 00/100 dollars (\$14,800.00); and

WHEREAS, the costs for the architectural and design services provided by the Authority is estimated at twelve thousand eight hundred and twenty-nine & 00/100 dollars (\$12,829.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager be and he is hereby authorized to execute a Change Order to the above contract with URS Consultants, Inc. in an amount not to exceed twelve thousand eight hundred twenty-nine & 00/100 dollars (\$12,829.00) for the design and engineering services necessary to complete the rehabilitation of the E. 75th and E. 79th Street bridge.

Section 2. That the General Manager be and he is hereby authorized to increase the contract with URS Consultants, Inc. by twelve thousand eight hundred twenty nine & 00/100 dollars (\$12,829.00) to a maximum total price of two hundred seventy four thousand six hundred nineteen & 00/100 dollars (\$274,619.00).

Section 3. That the General Manager's Change Order authority, pursuant to Section I-4.2.7.2 of the Greater Cleveland Regional Transit Authority Procurement Policy, is reauthorized.

Section 4. That is contract amendment shall be payable out of Capital Grant OH-03-0054.

Section 5. That said contract shall be binding upon and an obligation of the Authority and contingent upon compliance by the contractor to the Scope of Work and Addenda, if any; the Affirmative Action Plan adopted by the Board of trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligation of the Authority.

Section 6. That this resolution shall become effective immediately upon its adoption.
