

RESOLUTION NO. 1993-191

EXPRESSING APPRECIATION TO EARL MARTIN FOR HIS
SERVICE AS A MEMBER OF THE BOARD OF TRUSTEES OF THE
GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY AND

WHEREAS, Earl Martin served as a member of the Board of Trustees, having been sworn in on September 25, 1987, as a representative of the Cities, Villages, and Townships in Cuyahoga County other than the City of Cleveland; and

WHEREAS, Earl Martin served with distinction and took an active part in the deliberations of the Executive, Finance, Marketing & Communications (Vice Chairman), Operations and Legal Committees; and

WHEREAS, Earl Martin has contributed his expertise in management and public service, guiding the administration and Board of Trustees in governance changes and the establishment of clear-cut policies and procedures which have assisted the Board of Trustees in their role of policy makers.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the most sincere appreciation of the Board of Trustees is hereby extended to Earl Martin for his dedicated service to the Authority on behalf of the riding public and citizens of Cuyahoga County.


