## **RESOLUTION NO. 1993**-200

AUTHORIZING THE RENEWAL OF THE MAINTENANCE AGREEMENT WITH MOTOROLA C&E INC. FOR SYSTEM SUPPORT ON MOTOROLA DATA COMMUNICATION EQUIPMENT FOR A PERIOD OF TWO (2) YEARS COMMENCING JANUARY 1, 1994 THROUGH DECEMBER 31, 1995 FOR A TOTAL EXPENDITURE OF \$78,384.00 (GENERAL FUND, BUS EQUIPMENT DEPARTMENT BUDGET).

WHEREAS, the Traffic Communications System of the Greater Cleveland Regional Transit Authority consists of computer communications equipment purchased from Motorola Communications and Electronics Inc., located at 1309 E. Algonquin Road, Schaumburg, IL 70196-1080, over a period of time; and

WHEREAS, Motorola Communications and Electronic, Inc. owns the patents, copyrights and license for the software used by the Greater Cleveland Regional Transit Authority's communications System and is, therefore, a sole source provider in accordance with Ohio Revised Code 306.43(H)(3); and

WHEREAS, Motorola Communications and Electronics Inc. located at 12955 Snow Road, Cleveland, Ohio, 44130 is the local provider of system service; and

WHEREAS, this equipment is necessary for the proper and safe operation of the Authority's bus and rail service and must be maintained seven (7) days a week, twenty-four (24) hours per day; and

WHEREAS, to insure continuity of service, it is in the best interest of the Authority to enter into a two (2) year contract for said service.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Authority be and he is hereby authorized to enter into a two (2) year contract with Motorola C&E, Inc. for communication equipment system support services for the period January 1, 1994 through December 31, 1995.

Section 2. That said contract shall be payable out of the General Fund (Bus Equipment Department Budget), in a total amount of seventy-eight thousand three hundred eighty-four & 00/100 dollars (\$78,384.00).

Section 3. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the agreement and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.
