AUTHORIZING A CONTRACT WITH TOTH BUICK/PONTIAC FOR THE THE FURNISHING OF THREE (3) MID-SIZE AUTOMOBILES PURCHASED THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM AT THE TOTAL PRICE OF \$36,138.00 - (\$12,046.00 FROM THE RTA CAPITAL IMPROVEMENT FUND AND \$24,092.00 FROM CAPITAL GRANT OH-90-0102, \$19,273.60 IN FEDERAL FUNDS WHICH REPRESENTS 80% OF THE TOTAL COST OF TWO VEHICLES).

WHEREAS, the Board of Trustees by Resolution No. 1990-69 authorized utilization of the State of Ohio Cooperative Furchasing Program;

WHEREAS, the Cooperative Purchasing Program allows political subdivisions within the State of Ohio to purchase equipment through the Department of Administrative Services;

WHEREAS, the Department of Administrative Services has contracted with Toth Buick/Pontiac for the furnishing of mid-size automobiles as specified; and

WHEREAS, the General Manager has deemed it to be in the best interest of the Authority to utilize the State of Ohio Cooperative Purchasing Program for the purchase of three (3) mid-size automobiles at a total price of thirty-six thousand one hundred thirty-eight & 00/100 dollars (\$36,138.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Toth Buick/Pontiac, located at 3300 South Arlington Road, Akron, Ohio 44312, for the furnishing of three (3) mid-size automobiles for a total price of thirty-six thousand one hundred thirty-eight & 00/100 dollars (\$36,138.00) under the Department of Administrative Services Contract No. GDC-104-I.

Section 2. That said contract shall be payable out of the RTA Capital Improvement Fund in the amount of twelve thousand forty-six & 00/100 dollars (\$12,046.00) for one (1) mid-size automobile and Capital Grant OH-90-0102 in the amount of twenty-four thousand ninety-two & 00/100 dollars (\$24,092.00) for the remaining two vehicles.

Section 5. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to bid specification and addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements; and all applicable laws relating to the contractual obligations of the Authority.
