RESOLUTION NO. 1993- 221

AUTHORIZING A CONTRACT WITH THE FLXIBLE CORPORATION FOR THE PURCHASE OF FORTY EIGHT (48) 40' CNG TRANSIT COACHES FOR A PRICE OF \$12,436,224.00 - CAPITAL GRANTS OH-90-X166, OH-23-9010 AND OH-23-9011 (\$3,436,000.00, \$4,158,439.00, AND \$2,591,562.00 IN FEDERAL FUNDS WHICH REPRESENTS 80%, 85% AND 85%, RESPECTIVELY, OF THE TOTAL GRANT FUNDS) AND \$200,047.00 IN RTA CAPITAL FUNDS.

WHEREAS, the proposal of The Flxible Corporation located at 970 Pittsburgh Drive, Delaware, Ohio 43015 for a multiyear purchase of up to 65 CNG transit coaches with an option for an additional 15 coaches was received on the 27th day of September, 1993; and

WHEREAS, the General Manager has determined the offer of The Flxible Corporation to supply 65 40' CNG transit coaches, with an option for 15 additional coaches, as negotiated, to be the most advantageous to the Authority, price and other factors considered.

WHEREAS, currently available funding will allow for the purchase of 48 coaches.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the best and final offer of The Flxible Corporation made in response to GCRTA RFP#93082 be and the same is hereby accepted as the most advantageous offer to the Authority, price and other factors considered.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with The Flxible Corporation, and purchase 48 CNG transit coaches for a price of \$259,088.00 per coach for a total price of \$12,436,224.00.

Section 3. That said purchase shall be payable out of Capital Grants OH-90-X166, OH-23-9010 and OH-23-9011 in the amounts of four million two hundred ninety-five thousand & OO/100 dollars (\$4,295,000.00), four million eight hundred ninety-two thousand two hundred eighty-one & OO/100 dollars (\$4,892,281.00), and three million forty-eight thousand eight hundred ninety-six & OO/100 dollars ((\$3,048,896.00), and \$200,047.00 in RTA Capital Funds.

Section 4. That the General Manager be authorized to purchase up to 32 additional 40' CNG coaches, based on available 1994 Grant Funds at the price negotiated.

Section 5. That said contract shall be binding upon and in obligation of the Authority contingent upon appropriation for future contract years and upon compliance by the contractor to the scope of work; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 6. That this resolution shall become effective immediately upon its adoption.
