

RESOLUTION NO. 1993-222

AUTHORIZING A CONTRACT WITH HICKLING CORPORATION FOR PROJECT MANAGEMENT SERVICES FOR THE SOFTWARE DEVELOPMENT AND IMPLEMENTATION OF A CUSTOMER INFORMATION SYSTEM AND AMERICANS WITH DISABILITIES ACT RELATED SYSTEM AT A PRICE OF \$48,830.00 - CAPITAL GRANT OH-03-0113 (\$36,622.50 IN FEDERAL FUNDS WHICH REPRESENTS 75% OF THE TOTAL COST).

WHEREAS, the Greater Cleveland Regional Transit Authority has entered into an agreement with Multisystems, Inc. to design and develop a Customer Information System, and Americans with Disabilities Act Related System; and

WHEREAS, the Authority has deemed it necessary to seek technical expertise to ensure the successful management of this complex project; and

WHEREAS, the proposal of Hickling Corporation located at 8720 Georgia Avenue, Suite 1005, Silver Spring, Maryland 20910 to provide project management services for the software development and implementation of a Customer Information System and American with Disabilities Act related system was received on December 3, 1993; and

WHEREAS, Hickling Corporation submitted a negotiated offer to provide project management services at a price not to exceed forty-eight thousand eight hundred thirty & 00/100 dollars (\$48,830.00); and

WHEREAS, the General Manager deems Hickling Corporation to be the most qualified provider of the required project management services finds the negotiated price to be reasonable and therefore recommends the acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the proposal submitted by the Hickling Corporation on December 3, 1993 be and is hereby accepted as the most advantageous proposal for project management services for the software development and implementation of a Customer Information System and Americans with Disabilities Act Related System at a negotiated price not to exceed forty-eight thousand eight hundred thirty & 00/100 dollars (\$48,830.00).

Section 2. That said contract shall incorporate and be consistent with the proposal of Hickling Corporation dated December 3, 1993 as amended by negotiations.

Section 3. That said contract shall be payable out of Capital Grant OH-03-0113 in an amount not to exceed forty-eight thousand eight hundred thirty & 00/100 dollars (\$48,830.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent compliance by the contractor to the negotiated scope of work and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
