COMMENDING ANTHONY FORTINO FOR WINNING THE 1994 GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY PARATRANSIT ROADEO, AND REPRESENTING THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY IN THE 1994 OHIO PUBLIC TRANSIT ASSOCIATION/OHIO DEPARTMENT OF TRANSPORTATION STATE PARATRANSIT ROADEO IN COLUMBUS, OHIO, AND THE 1995 NATIONAL PARATRANSIT ROADEO IN PORTLAND, OREGON


