COMMENDING EMMETT DELIGATTI, PAUL SOBOL, AND DAVID THOMASON FOR WINNING THE 1995 GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY BUS MAINTENANCE ROADEO, AND REPRESENTING THE GREATER CLEVELAND REGIONAL TRANSIT AUTHORITY IN THE 1995 OHIO PUBLIC TRANSIT ASSOCIATION/OHIO DEPARTMENT OF TRANSPORTATION STATE BUS MAINTENANCE ROADEO IN DAYTON, OHIO, AND THE 1995 INTERNATIONAL BUS MAINTENANCE ROADEO IN ATLANTA, GEORGIA

WHEREAS, Emmett Delligatti, Paul Sobol, and David Thomason, Bus Mechanics from Brooklyn District, were the winners of the Ninth Annual Greater Cleveland Regional Transit Authority Bus Maintenance Roadeo in which Bus Mechanics representing various districts competed; and
