RATIFYING A PREVIOUS CHANGE ORDER OF \$500,000.00 AND AUTHORIZING A CHANGE ORDER TO CONTRACT NO. 93093 WITH PARSONS BRINCKERHOFF OHIO, INC. FOR THE FINAL DESIGN, ENGINEERING AND CONSTRUCTION DOCUMENTS AND CONSTRUCTION SUPPORT SERVICES FOR THE WATERFRONT TRANSIT LINE IN AN AMOUNT NOT TO EXCEED \$1,400,000.00 CAPITAL IMPROVEMENT FUND - 100% LOCAL FUNDS)

WHEREAS, The Board of Trustees, by Resolution No. 1993-20 authorized the General Manager to enter into a contract with Parsons Brinckerhoff Ohio, Inc. to provide professional architectural and engineering services for the preliminary engineering to design the Waterfront Transit Line at a cost not to exceed one million one hundred ninety-seven thousand one hundred seventy-five & 00/100 dollars (\$1,197,175.00);

WHEREAS, as part of the agreement the Authority reserved the right to obtain additional services which if included would allow the project to proceed utilizing a fast-track approach to achieve completion by June 1996.

WHEREAS, by Resolutions 1994-64, 1994-72, 1994-86, 1994-110, and 1995-44 the Board of Trustees previously authorized total increases in an amount not to exceed \$6,742,012.00 for final design and construction services; and

WHEREAS, the General Manager pursuant to his authority approved an increase in the amount of \$500,000.00 for continued construction design and support functions mostly related to rebidding of the station packages; and

WHEREAS, to maintain the completion schedule for the project, it has become necessary to obtain additional design and construction support services from Parsons Brinckerhoff, Ohio, Inc. in an amount not to exceed one million four hundred thousand & 00/100 dollars (\$1,400,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That changes approved by the General Manager pursuant to his delegatory authority to Contract No. 93093 with Parsons Brinckerhoff Ohio, Inc. authorizing a total price increase of five hundred thousand & 00/100 dollars (\$500,000.00) be and the same are hereby ratified.

Section 2. That the General Manager be and he is hereby authorized to execute a change order in an amount not to exceed one million four hundred thousand & 00/100 dollars (\$1,400,000.00) for Contract No. 93093 with Parsons Brinckerhoff Ohio, Inc. for completion of final design and additional construction services.

Section 3. That the total amount authorized for said contract is amended not to exceed a price of nine million eight hundred thirty-nine thousand one hundred eighty-seven & 00/100 dollars (\$9,839,187.00).

Section 4. That the General Manager's change order authority pursuant to Section I-4.2.7.2 of the Greater Cleveland Regional Transit Authority procurement policy is re-authorized for this procurement action.

Section 5. That said contract amendment shall be payable from the Greater Cleveland Regional Transit Authority Capital Improvement Fund (100% Local Funds).

Section 6. That all terms and conditions of the original contract will remain unchanged.

Section 7. That this resolution shall become effective immediately upon its adoption.
