

RESOLUTION NO. 1995 -139

AUTHORIZING CONTRACT #95097 WITH COMPUTER TASK GROUP, INC. FOR PROJECT MANAGEMENT SERVICES FOR THE IMPLEMENTATION OF A HUMAN RESOURCES/PAYROLL MANAGEMENT SYSTEM (ESTIMATED \$148,800.00), RTA CAPITAL FUND, INFORMATION SYSTEMS DEPARTMENT BUDGET.

WHEREAS, the Greater Cleveland Regional Transit Authority has entered into an agreement with PeopleSoft, Inc. to provide an integrated Human Resources/Payroll Management software system; and

WHEREAS, the Authority has deemed it necessary to seek technical expertise to ensure the successful management of this complex project; and

WHEREAS, the proposal of Computer Task Group, Inc. located at 6000 Lombardo Center, Suite 400, Seven Hills, Ohio 44131-2579 to provide project management services for the implementation of a Human Resources/Payroll Management System was received on September 11, 1995; and

WHEREAS, Computer Task Group, Inc. submitted a negotiated offer to provide project management services estimated at a price not to exceed one hundred forty-eight thousand eight hundred & 00/100 dollars (\$148,800.00); and

WHEREAS, the General Manager deems the negotiated offer of Computer Task Group, Inc. to be the most advantageous to the Authority, price and all other factors considered, and therefore recommends the acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of Computer Task Group, Inc., as negotiated, be and is hereby accepted as the most advantageous proposal for project management services for the implementation of a Human Resources/Payroll Management Software System at a price not to exceed one hundred forty-eight thousand eight hundred & 00/100 dollars (\$148,800.00).

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with the Computer Task Group, Inc. for project management services for the implementation of a Human Resources/Payroll Management Software System.

Section 3. That said contract shall be consistent with the proposal of Computer Task Group, Inc. dated September 11, 1995 as amended by negotiations.

Section 4. That said contract shall be payable out of RTA's Capital Fund in an amount not-to-exceed one hundred forty-eight thousand eight hundred & 00/100 dollars (\$148,800.00).

Section 5. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the negotiated scope of work and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 6. That this resolution shall become effective immediately upon its adoption.
