AUTHORIZING CONTRACT NO. 95094-B WITH SUSSEN, INC., FOR THE FURNISHING OF MOTOR COACH FILTERS, AS REQUIRED FOR A PERIOD OF ONE (1) YEAR IN AN AMOUNT NOT TO EXCEED THIRTY THOUSAND ONE HUNDRED SIXTY-EIGHT & 00/100 DOLLARS (\$30,168.00 - GENERAL FUND, INVENTORY DEPARTMENT BUDGET).

WHEREAS, the bid of Sussen, Inc., located at 6000 Carnegie Avenue, Cleveland, Ohio 44103, for the furnishing of motor coach filters, as specified and as required, was received on the 10th day of October, 1995 for the unit prices set forth in said bid, involving an estimated expenditure of thirty thousand one hundred sixty-eight & 00/100 dollars (\$30,168.00); and

Section 2. That the General Manager be and he is hereby authorized to enter into a contract with Sussen, Inc., for motor coach filters Item Numbers 7, 8, 10, 12, 14 and 20 of IFB No. 95094-B, as specified and required for a period of one year.
