

RESOLUTION NO. 1996- 19

**AUTHORIZING A CONTRACT WITH VARIOUS INDIVIDUALS AND COMPANIES FOR THE SALE OF THIRTY-NINE (39) SCRAP VEHICLES - W-2, X-22, X-34, E-44, E-46, E-47, 959, 963A, 987, 982, 970, 969, 968, 961, R-135, R-109, MT-5, R-107, 0331, 0332, 8495, C-073, X-31, C-072, X-54, C-74, R-105, P-177, P-178, M-95, F-153, E-87, MT-6, 962, 963B, 965, 967, 988, AND P-159, IN AN "AS IS" CONDITION FOR A TOTAL PURCHASE PRICE OF TWENTY-EIGHT THOUSAND ONE HUNDRED NINETY-THREE & 11/100 DOLLARS (\$28,193.11).**

WHEREAS, vehicles number W-2, X-22, X-34, E-44, E-46, E-47, 959, 963A, 987, 982, 970, 969, 968, 961, R-135, R-109, MT-5, R-107, 0331, 0332, 8495, C-073, X-31, C-072, X-54, C-74, R-105, P-177, P-178, M-95, F-153, E-87, MT-6, 962, 963B, 965, 967, 988, and P-159 have been determined to be obsolete in accordance with Authority's vehicle replacement policy; and

WHEREAS, the bids of various individuals and companies as listed below for said vehicles were received on the 25th day of January, 1996, for a total price of twenty-eight thousand one hundred ninety-three & 11/100 dollars (\$28,193.11); and

WHEREAS, the General Manager deems the bids of herein named individuals and companies to be the highest responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Michael R. Srampton, whose address is 7100 Columbia Road, Olmsted Township, Ohio 44138 for the purchase of R-107, 8485, and F-153 for a total purchase price of three thousand three hundred ninety & 58/100 dollars (\$3,390.58) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 2. That the bid of Sylvia Culora whose address is 3431 Lincoln Avenue, Parma, Ohio 44134 for the purchase of vehicle numbered E-44, for a total purchase price of six hundred & 00/100 dollars (\$600.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 3. That the bid of Dave Fisher whose address is 1277 Dock Road, Madison, Ohio 44057 for the purchase of vehicle numbered MT-6, for a total purchase price of one thousand seventy-eight & 67/100 dollars (\$1,078.67) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Kulp whose address is 2311 Montclair Avenue, Cleveland, Ohio 44109 for the purchase of vehicle numbered 982, for a total purchase price of seven hundred ten & 00/100 dollars (\$710.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 5. That the bid of Global Ground Services, Inc., located at 5851 South Cargo Road, Cleveland, OH 44135 for the purchase of vehicle numbered 0331. for a total purchase price of three hundred sixty-six & 00/100 dollars (\$366.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 6. That the bid of Fred Bement whose address is 19448 E. Bagley Road, Cleveland, Ohio 44130 for the purchase of vehicle numbered 961 for a total purchase price of one thousand six hundred two & 86/100 dollars (\$1,602.86) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 7. That the bid of Ted Pompei whose address is 4386 W. 226th Street, Fairview Park, Ohio 44126, for the purchase of vehicles numbered W-2, 987, 967, and 988, for a total purchase price of three thousand six hundred eighty & 00/100 dollars (\$3,680.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 8. That the bid of C & G Motors located at 3079 E. 55th Street, Cleveland, Ohio 44127, for the purchase of vehicles numbered X-22, X-34, E-46, E-47, 959, 963A, 970, 969, 968, R-135, R-109, MT-5, 0332, C-74, R-105, P-177, P-178, E-87, 962, 963B, 965, and P-159, for a total purchase price of twelve thousand fifty-three & 00/100 dollars (\$12,053.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 9. That the bid of Harold Ault whose address is 2633 Elizabeth Street, Avon, Ohio 44011, for the purchase of vehicles numbered X-31, C-072, X-54, and M-95, for a total purchase price of four thousand seven hundred twelve & 00/100 dollars (\$4,712.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 10. That the General Manager of the Authority be and he is hereby authorized to enter into contracts with the above listed individuals and companies for the sale of said vehicles as described on such terms as are appropriate for the protection of the interest of the Authority.

Section 11. That the proceeds of said sale in the amount of twenty-eight thousand one hundred ninety-three & 11/100 dollars (\$28,193.11) be deposited into the General Fund.

Section 12. That this resolution shall become effective immediately upon its adoption.
