

RESOLUTION NO. 1996-41

AUTHORIZING CONTRACT NO. 95136 WITH HOPKINS AIRPORT LIMOUSINE SERVICE, INC. FOR THE FURNISHING OF ADA/CRT SERVICE AS REQUIRED FOR A PERIOD OF ONE (1) YEAR WITH AN OPTION FOR AN ADDITIONAL ONE (1) YEAR OF SERVICE (\$1,122,000.00 - GENERAL FUND) PARATRANSIT DEPARTMENT BUDGET.

WHEREAS, the Greater Cleveland Regional Transit Authority has determined that a need for contracted ADA/CRT service exists to supplement services provided by the Paratransit Department and to comply with the requirements of the Americans with Disabilities Act; and

WHEREAS, the proposal of Hopkins Airport Limousine Service, Inc. located at 13315 Brookpark Road, Cleveland, Ohio 44181 for the provision of CRT/ADA service for a period of one year with an option for one (1) additional year was received on March 22, 1996; and

WHEREAS, after negotiations, Hopkins Airport Limousine Service, Inc. submitted a best and final offer for the period specified and any additional option periods of thirty-three & 00/100 dollars (\$33.00) per service hour resulting in a total estimated expenditure for the base year of the contract not to exceed one million one hundred twenty-two thousand & 00/100 dollars (\$1,122,000.00), based on anticipated usage; and

WHEREAS, the General Manager deems the offer of Hopkins Airport Limousine Service, Inc. to be the most advantageous to the Authority, price and other factors considered, and therefore recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer of Hopkins Airport Limousine Service, Inc., as negotiated, be and the same is hereby accepted as the most advantageous proposal for the provision of ADA/CRT service at a price of thirty-three & 00/100 dollars (\$33.00) per service hour for a total expenditure not to exceed one million one hundred twenty-two thousand & 00/100 dollars (\$1,122,000.00), for a one (1) year period, based on anticipated usage.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Hopkins Airport Limousine Service, Inc. for the provision of ADA/CRT service, for a one (1) year period, with the Authority retaining an option to extend said contract for an additional one (1) year period.

Section 3. That said contract shall be consistent with the proposal of Hopkins Airport Limousine Service, Inc. dated March 22, 1996, as modified by its best and final offer dated April 5, 1996.

Section 4. That said contract shall be payable out of the General Fund in an amount not-to-exceed one million one hundred twenty-two thousand & 00/100 dollars (\$1,122,000.00).

Section 5. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the negotiated scope of work and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 6. That this resolution shall become effective immediately upon its adoption.
