

RESOLUTION NO. 1997-7

AUTHORIZING CONTRACT NO. 96124A WITH OMNICORE TRUCK CENTERS, INC. dba RICHFIELD OIL CENTER, INC. FOR THE FURNISHING OF TRANSMISSION FLUID, AS REQUIRED FOR A PERIOD OF ONE (1) YEAR FOR AN ESTIMATED EXPENDITURE OF \$56,198.80 (GENERAL FUND, INVENTORY DEPARTMENT BUDGET)

WHEREAS, the bid of Omnicore Truck Centers, Inc. dba Richfield Oil Center, Inc. located at 2636 Brecksville Road, Richfield, Ohio 44286, for the furnishing of transmission fluid, as required was received on the 18th day of January, 1997, for the unit prices set forth in said bid involving an estimated expenditure of fifty-six thousand one hundred ninety-eight & 80/100 dollars (\$56,198.80); and

WHEREAS, the General Manager deems the bid of Omnicore Truck Centers, Inc. dba Richfield Oil Center, Inc. to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Omnicore Truck Centers, Inc. dba Richfield Oil Center, Inc. for the furnishing of transmission fluid, as required for a period of one (1) year, be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.


Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Omnicore Truck Centers, Inc. dba Richfield Oil Center, Inc. for the furnishing of transmission fluid, as required, for a period of one (1) year.

Section 3. That said contract shall be payable out of the General Fund (Inventory Department Budget), at the unit prices stated for an amount not to exceed fifty-six thousand one hundred ninety-eight & 80/100 dollars (\$56,198.80).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Bid Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1996-123; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
