

RESOLUTION NO. 1997 - 32

AUTHORIZING THE FILING OF AN APPLICATION WITH THE U.S.  
DEPARTMENT OF TRANSPORTATION FOR A GRANT UNDER SECTION  
5313(b) - COMPUTER INTEGRATED TRANSIT MAINTENANCE  
ENVIRONMENT SYSTEM

WHEREAS, the Secretary of Transportation is authorized to make grants for mass transportation projects; and

WHEREAS, the contracts for financial assistance will impose certain obligations upon the Greater Cleveland Regional Transit Authority; and

WHEREAS, it is required by the U.S. Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of applications for assistance under the Federal Transit Act of 1964, as amended, the Greater Cleveland Regional Transit Authority give assurance that it will comply with Title VI of the Civil Rights Act of 1964, and U.S. Department of Transportation requirements thereunder; and

WHEREAS, The Conference Report accompanying the 1997 Department of Transportation Appropriations Act earmarked funds for the Greater Cleveland Regional Transit Authority to develop the Computer Integrated Transit Maintenance Environment.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the General Manager of the Greater Cleveland Regional Transit Authority is hereby authorized to execute and file a grant application on behalf of the Greater Cleveland Regional Transit Authority with the U.S. Department of Transportation for research assistance under 49 U.S.C. Section 5313(b).

Section 2. That the General Manager of the Greater Cleveland Regional Transit Authority is hereby authorized to execute and file with such application, assurance or other documents required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964, as amended.


Section 3. That the General Manager of the Greater Cleveland Regional Transit Authority is authorized to furnish such additional information as the U.S. Department of Transportation may require in connection with the application or the project.

Section 4. That the General Manager of the Greater Cleveland Regional Transit Authority is authorized to accept the Federal funds from FTA, received pursuant to the grant for which this application is made.


Section 5. That, in the absence of the General Manager, the Acting General Manager of the Greater Cleveland Regional Transit Authority is hereby authorized to perform any or all of the above-described functions.

Section 6. That this resolution shall be effective immediately upon its adoption.
