

RESOLUTION NO. 1997- 144

AUTHORIZING CONTRACTS WITH VARIOUS INDIVIDUALS AND COMPANIES FOR THE SALE OF TWENTY-EIGHT (28) USED REVENUE AND NON-REVENUE VEHICLES IN AN "AS IS" CONDITION FOR A TOTAL PURCHASE PRICE OF SEVEN THOUSAND SEVEN HUNDRED FOURTEEN & 76/100 DOLLARS (\$7,714.76).

WHEREAS, the vehicles listed in the Attachment hereto have been determined to be obsolete in accordance with Authority's vehicle replacement policy; and

WHEREAS, the bids of various individuals and companies as listed in said Attachment for said vehicles were received on the 4th day of August, 1997, and

WHEREAS, the General Manager deems the bids of herein named individuals and companies to be the highest responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of James Kilbourne, whose address is 19623 Lake Road, Rocky River 44116 for the purchase of ten (10) vehicles as listed on the Attachment hereto for a total purchase price of four thousand fifty & 00/100 dollars (\$4,050.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder for sale vehicles.

Section 2. Section 9. That the proceeds of said sale in the amount of seven thousand seven hundred fourteen & 76/100 dollars (\$7,714.76) be deposited into the General Fund.
