

RESOLUTION NO. 1998-5

AUTHORIZING A CHANGE ORDER TO CONTRACT NO. 90165A WITH MILLAR ELEVATOR SERVICE COMPANY FOR ESCALATOR MONTHLY MAINTENANCE SERVICES AT A PRICE OF \$41,024.73 (GENERAL FUND - FACILITIES MAINTENANCE DEPARTMENT BUDGET)

WHEREAS, Resolution No. 1991-178 adopted on September 24, 1991 authorized a contract with Millar Elevator Service Company for routine monthly maintenance services at a price of two hundred sixty-eight thousand three hundred eighty & 00/100 dollars (\$268,380.00); and

WHEREAS, by Board Resolution No. 1997-29 change orders were approved establishing the total contract price as three hundred seventy-nine thousand four hundred eighty & 90/100 (\$379,480.90); and

WHEREAS, the General Manager used his change order authority to approve an additional ninety-eight thousand eight hundred forty-nine & 37/100 dollars (\$98,849.37); and

WHEREAS, it is necessary to fund an additional three (3) month time extension at a total cost of forty-one thousand twenty-four & 73/100 dollars (\$41,024.73).

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the price of Contract No. 90165A with Millar Elevator Service Company including changes approved by the General Manager, is hereby recognized as four hundred seventy-eight thousand three hundred thirty & 00/100 dollars (\$478,330.27).

Section 2. That an additional change order in the amount of forty-one thousand twenty four & 73/100 dollars (\$41,024.73) be authorized for a total revised contract price of five hundred nineteen thousand three hundred fifty five & 00/100 dollars (\$519,355.00).


Section 3. That said contract modification shall be payable from General Fund, Facilities Maintenance Budget, in an amount not to exceed forty-one thousand twenty-four & 73/100 dollars (\$41,024.73).


Section 4. That the General Manager be and he is hereby re-authorized to exercise his full change order authority under the Authority's Procurement Policy, Section I-4.2.7.2 as applied to Millar Elevator Service Company for Contract No. 90165A.

Section 5. All other terms and conditions of the contract shall remain unchanged.

Section 6. This resolution shall become effective immediately upon its adoption.
