WHEREAS, fifty (50) transit buses have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, the bids of four companies and two individuals for said vehicles were received on the 24th day of September, 1998; and

Woods to be the highest responsive bids from responsible bidders for the items identified in said Attachment A hereto and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of the DeMilta Iron & Metal Company, whose address is P.O. Box 748, Willoughby, Ohio 44094 for the purchase of twenty (20) vehicles as listed on Attachment A hereto for a total purchase price of two thousand nine hundred & 00/100 dollars (\$2,900.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 2. That the bid of NIMCO Shredding Company, whose address is P.O. Box 5157, Newark, NJ, 07105 for the purchase of fifteen (15) vehicles as listed on Attachment A hereto for a total purchase price of twelve thousand seven hundred fifty & 00/100 dollars (\$12,750.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 3. That the bid of the Midwest Bus Corporation, whose address is 1940 West Steward Street, Owosso, MI 48867 for the purchase of eight (8) vehicles as listed on Attachment A hereto for a total purchase price of four thousand & 00/100 dollars (\$4,000.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.
