

RESOLUTION NO. 1998- 151

AUTHORIZING CONTRACT NO. 98140 WITH SAFETYLANE EQUIPMENT CORPORATION FOR PROJECT 7.78 – THREE (3) ABOVE GROUND PARALLELOGRAM BUS LIFT INSTALLATION AT THE TRISKETT (2) AND BROOKLYN (1) DISTRICT BUS GARAGES - \$198,215.00 - RTA CAPITAL FUND, (BUS EQUIPMENT DEPARTMENT).

WHEREAS, the bid of Safetylane Equipment Corporation, located at 115 N. College Avenue, Suite 211, Bloomington, Indiana 47404 for Project 7.78 – Three (3) Above Ground Parallelogram Bus Lift Installations at the Triskett (2) and Brooklyn (1) District Bus Garages was received on November 24, 1998 in the amount of one hundred ninety-eight thousand two hundred fifteen & 00/100 (\$198,215.00) dollars; and

WHEREAS, the bid of Safetylane Equipment Corporation was the sole bid received; and

WHEREAS, in accordance with the Ohio Revised Code 306.43(B), when fewer than two responsive bids are received, a regional transit authority may negotiate a price with the sole responsive bidder or may rescind the solicitation and procure under division (H) (2) of the section; and

WHEREAS, negotiations have occurred and the bid price of one hundred ninety-eight thousand two hundred fifteen & 00/100 (\$198,215.00) dollars has been determined to be fair and reasonable to the Authority; and

WHEREAS, the General Manager deems the bid of Safetylane Equipment Corporation to be a responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Safetylane Equipment Corporation be and the same is hereby accepted as the sole responsive bid from a responsible bidder.

Section 2. That the General Manger of the Authority be and he is hereby authorized to enter into a contract with Safetylane Equipment Corporation to provide three (3) Above-Ground Parallelogram Bus Lift Installation at the Triskett (2) and Brooklyn (1) District Bus Garages under Project 7.78.

Section 3. That said contract shall be payable out of the RTA Capital Fund in the amount of one hundred ninety-eight thousand two hundred fifteen & 00/100 dollars (\$198,215.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specification and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1996-123; bonding and insurance requirements and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That this resolution shall become effective immediately upon its adoption.
