

Resolution No. 1999-8

A RESOLUTION APPOINTING TWENTY (20)
MEMBERS TO THE CITIZENS ADVISORY BOARD
FOR THE GREATER CLEVELAND REGIONAL
TRANSIT AUTHORITY

WHEREAS, the Greater Cleveland Regional Transit Authority recognizes the need to provide public transit service which provides a contribution to the neighborhoods of Greater Cleveland and the community as a whole; and

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority on October 20, 1998, Resolution No. 1998 -136 authorized the repeal of the Citizen's Advisory Committee and the American with Disabilities Act Committee; and

WHEREAS, the Board of Trustees of the Greater Cleveland Regional Transit Authority authorized a Citizen's Advisory Board of the Greater Cleveland Regional Transit Authority; and

WHEREAS, the purpose of this resolution is to appoint members to the Citizens Advisory Board (CAB) in response to Resolution 1998-136 established by the Greater Cleveland Regional Transit Board of Trustees on October 20, 1998.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority;

Section 1: That a Citizens Advisory Board be appointed within the organization of the Greater Cleveland Regional Transit Authority; and

Section 2: That the individuals named on the list attached hereto as Attachment A and incorporated as reference herein be appointed members of the Greater Cleveland Regional Transit Authority Citizens Advisory Board for the stated terms; and

Section 3: That their membership take effect immediately upon appointment by the Board of Trustees.
