AUTHORIZING CONTRACT NO. 99007A WITH DEMILTA IRON & METAL COMPANY; 99007B WITH NIMCO SHREDDING COMPANY; AND 99007C WITH DALE'S TRUCK PARTS INC. FOR THE SALE OF 28 USED TRANSIT VEHICLES IN AN "AS IS" CONDITION FOR A TOTAL SALE PRICE OF THIRTEEN THOUSAND NINE HUNDRED SEVENTY NINE & 00/100 DOLLARS (\$13,979.00).

WHEREAS, the vehicles listed in the attachment hereto have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, bids for said vehicles were received on the 11th day of March, 1999; and

WHEREAS, the General Manager deems the bids of the DeMilta Iron & Metal Company, NIMCO Shredding Company, and Dale's Truck Parts Inc. to be the highest responsive bids from responsible bidders for the vehicles as listed on Attachment A hereto and recommends acceptance thereof by the Board of Trustees.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of the DeMilta Iron & Metal Company, whose address is P.O. box 748, Willoughby, Ohio 44094 for the purchase of eight (8) vehicles as listed on Attachment A hereto for a total purchase price of one thousand one hundred sixty & 00/100 dollars (\$1,160.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder for said items.

Section 2. That the bid of the NIMCO Shredding Company, whose address is P.O. box 5157, Newark, NJ, 07105 for the purchase of nineteen (19) vehicles as listed on Attachment A hereto for a total purchase price of eleven thousand eight hundred nineteen & 00/100 dollars (\$11,819.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder for said items.

Section 3. That the bid of Dale's Truck Parts Inc., whose address is P.O. Box 2, Cedarville, OH 45314 for the purchase of one (1) vehicle as listed on Attachment A hereto for a total purchase price of one thousand & 00/100 dollars (\$1,000.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder for said item.

Section 5. That the General Manager of the Authority be and he is hereby authorized to enter into contracts with DeMilta Iron & Metal Company, NIMCO Shredding Company, and Dale's Truck Parts Inc. for the sale of said transit vehicles as described on such terms as are in the best interest of the Authority.

Section 6. That proceeds of said sale in the amount of thirteen thousand nine hundred seventy nine & 00/100 dollars (\$13,979.00) be deposited into the General Fund.
