

Resolution 1999- 155

AUTHORIZING CONTRACT NO. 99137 WITH DALE'S TRUCK PARTS INC. FOR THE SALE OF EIGHT (8) USED TRANSIT VEHICLES IN AN "AS IS" CONDITION FOR A TOTAL SALE PRICE OF FIVE THOUSAND EIGHT HUNDRED EIGHT & 08/100 DOLLARS (\$5,808.08).

WHEREAS, the vehicles listed in the attachment hereto have been determined to be obsolete in accordance with the Authority's vehicle replacement policy; and

WHEREAS, the bids of the five (5) companies as listed in said attachment for said vehicles were received on the 12th day of November, 1999; and

WHEREAS, the General Manager deems the bid of Dale's Truck Parts Inc. to be the highest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:


Section 1. That the bid of Dale's Truck Parts Inc., whose address is P.O. Box 2, Cedarville, OH 45314 for the purchase of eight (8) vehicles as listed on Attachment A hereto for a total purchase price of five thousand eight hundred eight & 08/100 dollars (\$5,808.08) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 2. That the General Manager of the Authority be and he is hereby authorized to enter into a contract with Dale's Truck Parts Inc. for the sale of said transit vehicles as described on such terms as are in the interest of the Authority.


Section 3. That proceeds of said sale in the amount of five thousand eight hundred eight & 08/100 dollars (\$5,808.08) be deposited into the General Fund.
